

2017 LA GALAXY II FAN EXPERIENCE SWEEPSTAKES OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.

ELIGIBILITY: The 2017 LA Galaxy II Fan Experience Sweepstakes (the “Sweepstakes”) is open to legal residents who live within a seventy-five (75) mile radius from Carson, CA (the “Territory”), who are the legal age of majority in the jurisdiction in which they reside (and at least 18 years old) at the time of entry. Employees, officers, and directors (including immediate family members (spouse, parent, child and sibling and their respective spouses, regardless of where they reside) and members of the same household, whether or not related) of Anschutz L.A. Soccer II, LLC (a/k/a LA Galaxy II), (“Sponsor”), United Soccer Leagues, L.L.C., and any of its participating teams, (“USL,” and collectively, with Sponsor and USL, the “USL Entities”) and each of their respective parents, affiliated companies, subsidiaries, licensees, distributors, dealers, retailers, printers and advertising and promotion agencies, and any and all other companies associated with the Sweepstakes are not eligible to participate or win a prize. By submitting your completed online entry form and survey as directed, you will receive one (1) entry in the Sweepstakes. All information submitted online by entrants is subject to, and will be treated in a manner consistent with Sponsor’s Terms of Service and Privacy Policy accessible at <http://www.lagalaxy.com/2>. Entrants must fully complete and submit all non-optional data requested on the online entry form to be eligible. Incomplete entries are void.

4. **Mail-in Method:** If you do not wish to complete a survey, you may enter the Sweepstakes by hand-printing your complete name, address, city, state and zip code, day & evening telephone number (including area code), date of birth and e-mail address (optional) on a 3"x5" postcard and mailing it in an envelope with proper postage affixed to: 2017 LA Galaxy II Fan Experience Sweepstakes, c/o Anschutz LA Soccer, Inc., ("LA Galaxy"), 18400 Avalon Blvd., Suite 200, Carson, CA 90746. Sponsor may use e-mail addresses provided via the Mail-in entry method (as applicable) for prize notification purposes only; however, eligibility to participate in the Sweepstakes is not dependent upon entrant's provision of this information. Mail-in entries must be postmarked by October 31, 2017 and received by Sponsor no later than November 7, 2017 to be eligible. Mail-in entries become the property of the Sponsor and will not be returned.

USE OF DATA. Sponsor will be collecting personal data about participants (including, without limitation, name, phone number, mailing address, gender, age, e-mail addresses) when they enter the Sweepstakes online. Sponsor is entitled to use personal data contained in all entry forms, on-line or otherwise, in accordance with the Sponsor's privacy policy. Furthermore, survey responses may be shared with the USL and by participating entrants agree that such data will be used in accordance with the terms and conditions of USL's privacy policy and terms of service at <http://www.uslsoccer.com/>.

RANDOM DRAWING: Three (3) potential Winners of the Sweepstakes (each a "Winner," and collectively the "Winners") will be selected by random drawing on or about November 7, 2017 from among all eligible entries received by the Sponsor. The decisions of Sponsor are final and binding on all matters relating to this Sweepstakes. Odds of winning depend on the total number of eligible entries received during the Entry Period.

PRIZES: Three (3) prizes are available to be awarded (each a "Prize," and collectively the "Prizes") as follows:

All disputes will be resolved under applicable U.S. laws in the County of Los Angeles, State of California

without giving effect to choice of law or conflicted law principles (whether of the state of California, or any other jurisdiction), which would cause the application of the laws of any jurisdiction other than the state of California. Sponsor's failure to enforce any terms of these Official Rules shall not constitute a waiver of that provision.

The Sponsor and USL Entities, as applicable, reserve the right, in their sole discretion, to cancel or suspend the Sweepstakes for any reason, including should virus, bugs, unauthorized human intervention, or other causes corrupt the administration, security, fairness, integrity or proper operation of the Sweepstakes. In the event of cancellation, Sponsor may elect to identify the Winners and award the Prize by way of random drawing from among all non-suspect, eligible entries received up to the time of such cancellation.
