

LA GALAXY 2018 YEAR END SURVEY SWEEPSTAKES OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.

ELIGIBILITY: LA Galaxy 2018 Year End Survey Sweepstakes (the "Sweepstakes") is open to legal U.S. residents who are at least the legal age of majority in the jurisdiction in which they reside (and at least 18 years old) at the time of entry, and who live within a seventy-five (75) mile radius from the City of Carson, California. Employees, officers and directors (including immediate family members (spouse, parent, child and sibling and their respective spouses, regardless of where they reside) and members of the same household, whether or not related) of Anschutz L.A. Soccer, Inc., a/k/a LA Galaxy (the "Sponsor"), Major League Soccer, L.L.C. ("MLS"), and Soccer United Marketing, LLC ("SUM") (collectively, with Sponsor and MLS, the "MLS Entities") and each of their respective parents, affiliated companies, subsidiaries, licensees, distributors, dealers, retailers, printers and advertising and promotion agencies, and any and all other companies associate with the Sweepstakes are not eligible to participate or win a prize. The Sweepstakes is subject to all applicable federal, state, and local laws, rules and regulations. Void outside California and where prohibited or restricted by law, rule or regulation.

HOW TO ENTER: The Sweepstakes begins at 10:00 a.m. Pacific Standard Time ("PST") on November 8, 2018 and ends at 11:59 p.m. Pacific Standard Time ("PST") on November 25, 2018 ("Entry Period"). During the Entry Period, there are three (3) ways to enter: if you receive an email from Sponsor, online, or by mail. No other method of entry will be accepted. Limit one (1) entry per person, per e-mail address, and per household, regardless of method of entry. Multiple entries received from any person or e-mail address or household in excess of the stated limitation will be void.

1. **Email Recipient Method:** During the Entry Period, if you receive an email from Sponsor, click on the banners, buttons and/or links to access the online entry form for the Sweepstakes. By submitting your completed online entry form (including the survey) as directed, you will receive one (1) entry in the Sweepstakes. All information submitted online by entrants is subject to, and will be treated in a manner consistent with MLSsoccer.com's Terms of Service accessible at <http://www.mlssoccer.com/terms-of-service> and Privacy Policy accessible at <http://www.mlssoccer.com/privacy-policy> (both of which are incorporated herein by reference). Entrants must fully complete and submit all non-optional data requested on the online entry form to be eligible. Incomplete entries are void. Online entrants to the Sweepstakes will be given the option to receive commercial e-mails from MLS Entities; however, eligibility to participate in the Sweepstakes is not dependent upon entrant's consent to receive such e-mails and consenting to do so will not increase your chances of winning.

2. **Online Survey Method.** You can enter the Sweepstakes online during the Promotion Period by accessing and completing the LA Galaxy 2018 Year End Survey (the "Survey") located at <https://aeg.turnkeysurveyor.com/se/5F2BD383508926F3>. Follow the instructions on the screen and complete the online Survey. You must complete all required information in order to be eligible. Limit one (1) entry per person, per household and per valid e-mail address. More than one (1) entry from any person, household or from any e-mail address will void all entries from that person or e-mail address, as applicable. Any attempt by a person to enter more than once with multiple email accounts or mailings may result in disqualification at the discretion of Sponsor upon verification of prize winner

Mail-in entries must be postmarked by November 25, 2018 and received by Sponsor no later than December 2, 2018 to be eligible. Mail-in entries become the property of the Sponsor and will not be returned.

RANDOM DRAWING: Two (2) potential winners of the Sweepstakes (each a "Winner," and collectively, the "Winners"), will be selected by random drawing on or about December 3, 2018, from among all eligible entries received by the Sponsor. NOTIFICATION: Potential Winners will be notified by e-mail, mail and/or telephone (in the sole discretion of Sponsor and/or the applicable MLS Entity, as applicable) by the Sponsor. In the event that any potential Winner does not respond to any such notification within forty-eight (48) hours of the first attempt by Sponsor, a disqualification will result, Prize will be forfeited and, at Sponsor's sole discretion and time permitting, an alternate potential Winner may be chosen from among all remaining eligible entries. Potential Winners may be required to submit his/her valid social security number (if applicable) and/or other identification to Sponsor and will be required to execute, have notarized and return an Affidavit of Eligibility and Release of Liability and, unless prohibited by law, Publicity, within five (5) days of the date of issuance.
