

2024 LA GALAXY BIRTHDAY CLUB

Terms and Conditions

NO PURCHASE IS NECESSARY TO REGISTER. VOID WHERE PROHIBITED OR RESTRICTED BY LAW.

The 2024 LA GALAXY BIRTHDAY CLUB (“Club”) rewards eligible participants who register for the Club with a special birthday gift delivered via email as set forth herein.

- 1. Eligibility.** The Club is open only to legal residents of California, who are 18 years of age or older at time of registration and reside within a seventy-five (75) mile radius of Carson, CA. Void outside of California and where prohibited or restricted by law, rule or regulation. Employees of Anschutz L.A. Soccer, Inc. (a/k/a LA Galaxy), Anschutz Entertainment Group, Inc., Anschutz Southern California Sports Complex, LLC, Major League Soccer, L.L.C. (“MLS”), Soccer United Marketing, LLC (“SUM”), Pro Soccer Development, LP (“MLSNP”), and/or Player Development, LLC (“PDEV,” and together with MLS, SUM, and MLSNP, the “MLS Entities”), and each of their respective affiliates, owners, subsidiaries, advertising or promotion agencies are not eligible, nor are members of these employees' families (defined as parents, children, siblings, spouse, and life partners) and members of the same household, whether or not related. Proof of residency and age may be required. All federal, state and local laws and regulations apply. **Club registration is good only for the 2024 LA Galaxy MLS Season.**
- 2. How to Enter:** Participants can register for the 2024 Club at www.lagalaxy.com/birthday beginning at 12:00 p.m. Pacific Standard Time (“PST”) on February 15, 2024 and ending at 12:00 p.m. Pacific Daylight Time (“PDT”) on August 31, 2024 (“Registration Period”). Eligible participants (each a “Member,” and collectively, the “Members”) must follow the instructions on the screen. Members must provide all required information in order to be eligible (name, email address, phone, date of birth, and zip code). **Limit one (1) registration, one (1) birthday gift, and one (1) code per Member.**

Birthday email will be sent by the LA Galaxy to the email address contained in the Member's registration on or around the 1st day of the Member's birthday month, except for Members with birthdays in the following MLS Off-Season months: (i) January and February, 2024 which emails will be sent by the LA Galaxy on or around March 1, 2024, or (ii) October, November and December 2024, which emails will be sent by the LA Galaxy on or around September 1, 2024 **Please note that there is currently only one (1) LA Galaxy regular season home game scheduled during the month of October, 2024.** Registrations received from any person or e-mail address in excess of the stated limitation will be void. Any attempt by a person to register with multiple email accounts may result in disqualification at the discretion of the LA Galaxy upon verification. (b) For Members with birthdays occurring during the MLS Off-Season months of January 2024 or February, 2024, (i) a special birthday code will be sent to Member via email only, redeemable for two (2) complimentary tickets located in Endline seating at Dignity Health Sports Park for use by Member and one (1) guest to attend one (1) LA Galaxy regular season home Game occurring during the months of March or April, 2024 (ARV of two (2) Game tickets: \$50.00). **Ticket service fees will apply and will be the sole responsibility of Member at the time of redemption. Service fee not to exceed: \$10.00 per ticket. Galaxy reserves the right to provide tickets in a month other than as set forth above if tickets are not available as determined by Galaxy in its sole determination in the designated month(s).** Member may have the ability to upgrade ticket location at time of redemption subject to availability, as determined by LA Galaxy, and provided Member must pay for any difference in the retail price of such upgraded tickets at the time of the

Service fee not to exceed: \$10.00 per ticket. Galaxy reserves the right to provide tickets in a month other than as set forth above if tickets are not available as determined by Galaxy in its sole determination in the designated month.** Member may have the ability to upgrade ticket location at time of redemption subject to availability, as determined by LA Galaxy, and provided Member must pay for any difference in the retail price of such upgraded tickets at the time of the upgrade request, as well as any additional service fees per upgraded ticket (which may exceed \$10.00). Codes must be redeemed within forty-eight (48) hours prior to the selected Game. Codes void after October 3, 2024. All tickets must be used by October 5, 2024.** Tickets are not eligible for transfer or resale. Each Member's guest must be of legal age of majority in their jurisdiction of residence, unless guest is the child or legal ward of Member.

Ticket codes and other discount codes cannot be combined with any other offers. Not valid for previously purchased LA Galaxy game tickets. Codes will not be replaced if lost or stolen, and codes have no cash value.

Tickets do not include meals, beverages, parking, travel to/from Dignity Health Sports Park, gratuities, service fees, or any other expenses of a personal nature, unless otherwise set forth above. Except where otherwise expressly noted in these Terms and Conditions, the selection of all vendors, gifts, products and services is subject to the LA Galaxy's sole and absolute discretion. Gift (and/or any portion thereof) is nontransferable and non-exchangeable. No substitutions or cash redemption of the Gift is permitted except that LA Galaxy retains the right to substitute a gift of equal or greater retail value (or at LA Galaxy's election, the cash value of the applicable gift). All Members and their guests agree to comply with all applicable stadium regulations in connection with any tickets to Game. LA Galaxy and/or stadium operator reserve the right to remove or deny entry to any Member and/or any guest who engage in a non-sportsmanlike or disruptive manner, or with intent to annoy, abuse, threaten or harass any other person at the Game.
